01 Letter from the chairman



I am happy to present the Activity Report of the Fundación Jesús Serra where, for the second year in a row, we report on our performance to society and

our stakeholders. This document reviews the main projects and initiatives that we carried out in 2019, including a brief summary of the entity's accounts. It provides a simple and clear overview of who we are, our history, our governing bodies, our main lines of activity, our impact on the Sustainable Development Goals (SDG) and financial information.

The action plan was approved by our board on 28 November 2018 in the abridged annual accounts, which are presented in accordance with the regulatory framework on financial reporting applicable to the foundation in Spain, and whose audit report was dated 28 June 2019. Both documents are available on the corporate website

(https://www.fundacionjesusserra.org/eng/get-toknow-us#annual-accounts).

In 2019, our initiatives benefited 17 people and 46 entities in 8 countries, through 55 actions spread across five lines of action: research, business and education, social action, sport and promoting the arts. It should also be noted that 84% of these projects were conducted directly. This activity is consistent with the Corporate Responsibility Policy and Master Plan of the Grupo Catalana Occidente.

The role of the Fundación Jesús Serra is particularly relevant in the development of one of the key aspects of who we are: our commitment to society. In fact, the Foundation is the main instrument through which the social action initiatives of the Grupo Catalana Occidente and its companies are channelled.

The activity of the Fundación Jesús Serra impacts on the United Nations' Sustainable Development Goals due to its very nature. Through this Report, we showcase our commitment to achieving these global commitments and take on our mission in fulfilling the Agenda 2030. SDG 3 Good health and wellbeing and SDG 4 Quality education are the priorities within our framework of action.

The publication of this Report coincides with the major health and humanitarian crisis arising from COVID-19 in Spain and around the world. The Fundación Jesús Serra has gone all out to provide urgent assistance in this dual dimension. On the one hand, a significant donation was made to one of the research groups of the Spanish National Research Council (CSIC), which is leading several projects to protect the population from infection so that we can have medical solutions to deal with the pandemic. On the other hand, from a perspective of

humanitarian solidarity, we have collaborated with several organisations to try to minimise the effects of this unprecedented situation on families in a particularly vulnerable situation, guaranteeing children their right to education and addressing the negative economic and psychosocial effects of this crisis. All these actions will be subject to further detail in the Foundation's next Activity Report.

Returning to the year we are focusing on here, 2019, I encourage you to read this Report and send us your opinions and suggestions so that we can enhance its content and continue to improve.

I would like to take this opportunity to express my gratitude for the excellent work done by the teams of all the companies we work with and, of course, by the people who make up our Foundation. Together we have achieved excellent results with the common goal of bringing our actions to more people and benefiting society.

The Fundación Jesús Serra was born under the wing of Grupo Catalana Occidente in 1998 with the purpose of channelling the sponsorship and patronage activities that the insurance company had been carrying out throughout an entire century. Its original name — Fundación Catalana Occidente — was replaced by the current one, Fundación Jesús Serra, in 2006, as a tribute to the figure Jesús Serra Santamans, founder of the Group and a staunch advocate, from the private sphere, of humanitarian values and spirit in benefit of the community.

At this stage, the Foundation follows the path marked by its promoter and fosters a multitude of projects based around research, business and teaching projects, social action, sport and promoting the arts. These initiatives are developed directly or in collaboration with other institutions, in order to promote the Grupo Catalana Occidente's work and commitment to society.

Jesús Serra was mainly known for having founded Grupo Catalana Occidente and having dedicated his professional life to the world of insurance, becoming one of the most important personalities in this sector in Spain. A man of extraordinary business talent, besides Grupo Catalana Occidente he also founded other important companies and institutions during his extensive career, and he spearheaded multiple projects to which he always contributed a positive and visionary spirit that made him worthy of numerous awards.

Throughout his life, he maintained a special interest for the arts, pursuing music and poetry with passion, and for sport, which he not only participated in but also actively promoted through various initiatives, particularly related to tennis and skiing.

However, if there was one thing that characterised him, it was his great humanitarian spirit, with a particular affiliation for those most in need. This trait was reflected in the intense social work that was always present throughout both his professional and personal life. The Fundación Jesús Serra keeps its interests and social work alive through the various projects it carries out.

The Foundation participates in initiatives to benefit certain groups, 84% of which were carried out directly in the year and 16% indirectly. Most of these projects and initiatives were carried out with impact assessment and development programmes.

07 Lines of action

Since it was created in 1998, first as the Fundación Catalana Occidente and since 2006 as the Fundación Jesús Serra, a wide range of projects have been promoted in different areas of activity within the fields of research, business and teaching, social action, sport and promoting the arts.

- Research: the Foundation's activities are focused on financing, promoting, developing and disseminating research in the field of biomedical science, food and nutrition, as well as research into cardiovascular and oncological diseases.
- Business and Teaching: the Foundation's activity consists of financing, promoting and disseminating teaching, academic and creative talent, financial education, entrepreneurial attitudes and new educational, technological and economic conditions.


- Social Action: the Foundation develops and participates in various types of projects, including those related to integration into society, the development of socio-occupational conditions among people with physical or intellectual disabilities, women and minors at risk, improving healthcare and combating child malnutrition.
- Sport: the Foundation organises sports championships and tournaments, also promoting sports among people with physical disabilities and team sport.
- Promoting Arts: the Foundation supports the creation, production and dissemination of art by people who are starting and/or developing their work in different artistic fields, mainly in the field of poetry and music, specifically piano performances.

In 2019, the Foundation's total budget was €2.3m, €2m of which was invested into the founding goals, which correspond to the development of all the activities and projects provided for in the plan approved by the Project Assessment Committee, and subsequently by the Board.





Our collaboration with this entity is materialised in the scholarship programme África Digna -Fundación Jesús Serra, whose objective is to provide access to secondary and university education to female Kenyan students that have a good academic record but scarce economic resources. This initiative covers their studies costs and monitors their progression.

In 2019, 15 girls were awarded a scholarship at Loreto High School Limuru, located about 30 km from Nairobi, and 5 university students were awarded a scholarship at different universities in Kenya, all of whom had also graduated from Loreto thanks to the Fundación Jesús Serra scholarships.

Save the Med

Save the Med aims to contribute to the development of a network for the conservation of protected marine areas, as well as working to help the ecosystem regain balance and well-being. The scientific teams and divers use cutting-edge science to create a network of Protected Marine Areas (PMAs) around the Balearic Islands, with the aim of restoring the Mediterranean Sea's biodiversity so that it can prosper harmoniously.

Save the Med and Fundación Jesús Serra both work on the Changemakers at Sea project: a programme from the combination of scientific research and the most innovative educational projects. We encourage participants, aged between 15 and 18 and who are part of the 'Dos Manos' (Two Hands) school programme, to take action to combat plastic pollution through developing awareness-building projects. The winning team will have the opportunity to sail on board the research vessel Toftevaag as part of the crew, helping in the study of whales, dolphins, turtles, seabirds and plastics in the marine ecosystem.

3rd edition of the Xpress Tennis Cup to promote tennis

The Grupo Catalana Occidente's Fundación Jesús Serra held a highly successful 3rd edition of the Xpress Tennis Cup in 2019. This is a sports project aimed at promoting tennis among 5–12-year-olds and has seen the participation of young tennis players increase year after year. From March to June, more than 1,500 players from Valencia, Catalonia and the Community of Madrid represented their tennis clubs in this tournament, which is characterised by its innovative format of short 20-minute matches. This competition system is very participative and empowers sportsmanship.

A total of 270 teams from these three autonomous communities shared their passion for tennis while

associated with sport, such as teamwork, effort and perseverance. After the provincial phases held in each of the autonomous communities, a grand final was held in each of them.

12th Ski Trophy of the Fundación Jesús Serra in Baqueira Beret, with record participation levels

The championship took place at the Valle de Arán ski resort in March 2019, and closed with a total of 262 participants, topping the previous edition by more than 100 people.

It featured world, European and Paralympic champion Jon Santacana and his partner Miguel Galindo, both sponsored by the Fundación Jesús Serra Foundation, who opened the event and participated in the awards ceremony. As testament to the inclusivity of the competition, one participant had a visual disability and another had a physical disability.

262 skiers participated in the Giant trial, spread across 22 different categories, having to get past 24 gates before reaching the finish line. The top 32 male racers and the 16 top female racers were classified for the tournament's final the next day in a knockout parallel run.

The aim of the social project 'My turn to play!', organised in collaboration with the Maria Canals International Music Competition Association, is to encourage musical practice among children in a situation of social vulnerability.

In neighbourhoods of Madrid, Barcelona and Seville, in coordination with schools, auditions are held with children aged 6-7 getting familiar with the grand piano. Students who show the most skills, attitude and commitment are awarded a scholarship to receive piano lessons for two school years.

The Fundación Jesús Serra held the twelfth edition of its Poetry Competition, which recognises poetic creation in Spanish and Catalan. In 2019, this competition received record participation with over 1,000 poems submitted, divided into three categories: 'A' for participants over 18 years old, with a prize of €2,500; 'B', for authors between 14 and 17 years old, with a prize of €1,500 and 'C', aimed at participants between the ages of 10 and 13 years, with a prize of €800.

Over 1,000 poems were submitted, 12% in Catalan and 88% in Spanish. Participation in the categories of children and young people increased compared with previous editions, 15% corresponding with poems presented by children under 17 years of age. The participating poets were mostly Spanish nationals, although some entries were submitted by participants from countries in Latin America as well as the United States.

13 Commitment to Sustainable Development Goals

2019 activity report - Fundación Jesús Serra

The activity of the Fundación Jesús Serra impacts on the United Nations' Sustainable Development Goals due to its very nature, which is materialised in initiatives, programmes and published information. Through this Activity Report, the Foundation showcases its commitment to the SDGs and takes on its mission in complying with the Agenda 2030, acting as a promoter of social action within the Grupo Catalana Occidente.

Good health and well-being and quality education are the priority SDGs, and account for a larger number of actions.

Health is a fundamental human right. The Agenda 2030 includes universal access to reproductive and sexual health services and the reduction of infant, maternal and premature mortality in vulnerable regions. The Fundación Jesús Serra focuses its efforts on achieving these goals with initiatives such as the 'Lluisa Farré' project in Senegal, aimed at preventing and treating complications arising from births that result in high maternal and neonatal mortality. Another example is support for building hospitals



in order to reduce child mortality and improve medical training in countries such as Guinea Bissau and Ethiopia. One of the basic pillars for promoting this SDG 3 is investment in health research, which is the subject of the Fundación Jesús Serra Research Awards for food and nutrition, distinguishing basic and clinical categories.

SDG 3 Good health and well-being is a crossdisciplinary commitment that relates to other objectives such as SDG 1 No Poverty and SDG 2 Zero Hunger, since most diseases are the result of malnutrition or poor eating habits. In this regard, the Foundation contributes through activities that support the Food Bank, or collaborating with entities such as Children's Villages to protect minors at risk.

Education is a priority for the development of a better quality of life, and a positive impact on the environment and the economy. The agenda of the Sustainable Development Goals (SDGs) and the 2030 Education Action Framework are intended to ensure comprehensive global schooling, paying particular attention to vulnerable social groups or groups at risk of poverty. The Fundación Jesús Serra works to ensure equality in learning opportunities and to prevent the loss of talent and human potential,

promoting the achievement of SDG 4. In this regard, we can highlight projects for the rehabilitation and construction of schools in disadvantaged areas, education programmes to promote healthy habits, and training grants for young students in Kenya or people with different capacities.

Universal and quality education will promote the eighth Sustainable Development Goal (SDG), focusing on creating decent employment and economic growth. Projects such as the 'Employability Analysis Service' for people with different capacities are an example of our support for this objective.

From now until 2030, the Fundación Jesús Serra will focus part of its efforts to facilitate access to work among groups with fewer opportunities or those at





risk of social exclusion. This work is carried out with respect to the culture and social reality of the countries where the projects are carried out, promoting integration into the world of work for women, young people, people with disabilities, families with limited resources or those affected by the digital divide. SDG 10 'Reduced Inequalities' is also being promoted.

The current challenge of the Fundación Jesús Serra is to deepen the link between its pillars of action and the different SDGs, integrating them as a fundamental criterion when defining new projects or resizing existing ones. While fully respecting our statutory objectives, and the humanist and philanthropist spirit of our founder, Jesús Serra Santamans, who inspired our beginnings and the specificities of the Foundation, we will continue to align our activity in a manner consistent with the SDGs we consider to be priorities. In this regard, we will contribute more value to the initiatives we develop, whilst helping to consolidate the overall commitment of the Grupo Catalana Occidente.
